

ELECTRONIC EFTCO CLEANING DOCUMENT (eECD)

The EFTCO Cleaning Document (ECD) is a support document for every single tank cleaning in the supply chain process. It is a documentation of the performed cleaning process. The uniform EFTCO Codes describe these steps and are multilingual available in all European languages.

The ECD is under copyright by EFTCO and the use of this document is restricted to quality approved cleaning stations being a member of a national association.

EFTCO, CEFIC / essenscia and ECTA has started a project and merged efforts to digitalize the existing paper version of the EFTCO Cleaning Document (ECD) into the

ECLIC has received the usage rights of the ECD and is allowed to use the ECD as electronic EFTCO Cleaning Document (eECD) and the EFTCO codes in digital format for issuing to the Industry.

European rollout of the eECD has started and registered cleaning stations are able to provide the eECD as documentation of the provided tank cleaning services. The worthiness of the eECD information is of same high value as the used paper documentation of the EFTCO Cleaning Document.



Rollout of the eECD will make it necessary to provide either electronic or paper ECD based on the demand of the next loading place.

Cleaning stations are instructed to either use the eECD or paper ECD as documentation of the cleaning services. The use of eECD and paper ECD for the same cleaning is not allowed as this will generate 2 original cleaning documents which is not allowed.

The place of loading will continue to collect the paper ECD to avoid double use and is also requested to electronically mark an eECD as `used` during gate in control process.

Using the electronical ECD is a documentation and communication between registered partners of the logistic chain.

The use of the electronic ECD includes the possibility of creating a printed eECD version.

Deviating from the paper ECD rules for ECD Box14, that the name and the signature of the person in the cleaning station is mandatory, the eECD allows a signature from the Cleaner or Supervisor by writing the name in capital letters for electronical signature. A handwritten signature s not necessary by using the eECD.
